



Wahlen in den Ausland- schweizererrat für 2009-2013

Die Neuwahlen für die Amtsperiode 2009-2013 finden in Südafrika im ersten Halbjahr 2009 durch die 9 Schweizervereine statt.

Es sind dies die 9 Vereine die der Auslandschweizerorganisation (ASO) in Bern angeschlossen sind, nämlich: Swiss Social and Sports Club und Swiss Rifle Club in Cape Town; Swiss Club Natal in Durban. Swiss Society Helvetia, Swiss Rifle Club und Swiss Choir in Johannesburg, Swiss Club Far North in Makhado (früher Louis Trichard), Swiss Club Eastern Cape in Port Elizabeth sowie Swiss Society Alpina in Pretoria.

Keine Stellvertreter mehr

Die Neuwahlen wurden in der Swiss Revue Oct.08/Nr.5 ausgeschrieben. Bis zum 31.1.09 können sich die gegenwärtig amtierenden ASR Delegierten sowie immatrikulierte Schweizerinnen und Schweizer bei ihrem Schweizerverein als Kandidaten für die neue Amtsperiode anmelden. Bis jetzt hatte Südafrika zwei Delegierte und zwei Stellvertreter im Auslandschweizererrat. In der nächsten Amtsperiode fällt das Amt der Stellvertreter weg und es werden noch zwei Delegierte zu wählen sein. Ziel der Neuverteilung der Sitze ist es, einer grösseren Anzahl Ländern einen Sitz im ASR zu ermöglichen. Die Schweizervereine stimmen an ihrer GV im Frühjahr 2009 über die Wahl der Kandidaten ab.

Wie schon vor 4 Jahren hat mich der Vorstand der ASO zum

Electoral Officer für Südafrika ernannt. Ich habe die Präsidenten der neun obenerwähnten Vereine über den Wahlmodus informiert. Jeder Verein, ob gross oder klein, hat ein Stimmrecht pro Kandidat. An den Sitzungen in Bern wird deutsch oder französisch gesprochen. Es ist wichtig, zwei Schweizerinnen oder Schweizer zu finden, die bereit sind und die Zeit haben, sich für vier Jahre als ASR Delegierte wählen zu lassen und als unsere Vertreter in Bern aktiv mitzuarbeiten. 700'000 Auslandschweizer

Der Auslandschweizererrat (ASR) ist das repräsentative Organ der Auslandschweizerinnen und Auslandschweizer. Er vertritt die Interessen aller ausgewanderten Schweizerinnen und Schweizer in den politischen Kreisen der Schweiz. Der ASR spielt somit eine entscheidende Rolle für die Wahrung der Interessen der Auslandschweizer. Er ist das „Auslandschweizer-Parlament“, das legislative Organ der Auslandschweizer-Organisation (ASO) und tritt zweimal jährlich in der Schweiz zusammen. Von den insgesamt 700'000 im Ausland lebenden Schweizern sind fast 120'000

im Wahlregister eingetragen, um von ihrem Stimmrecht Gebrauch zu machen. Wenn alle Auslandschweizerinnen und Auslandschweizer einen Kanton bilden würden, wäre dieser bevölkerungsmässig der drittgrösste der Schweiz. Es ist deshalb wichtig, dass ihre Interessen auch in der Schweiz vertreten werden.

Hans-Ulrich Tanner's review

Swiss Consul General Hans-Ulrich Tanner says goodbye after three years in Cape Town and South Africa.



Looking back different thoughts come into my mind: Not long after my arrival Helen Zille took over the Mayor's Office from Nomaindia Mefeketo. By opening up council business to the public, the DA administration successfully created a different image. Zilles credo to cut down symbolism and get to substance had a positive impact on the working relation between the Consulate General and the City. One good example of cooperation between the City and the Consulate was the exhibition "Etre - The Face of Human Rights" which was officially opened in the Civic Centre by the Mayor in February 2007, coinciding with the Mayor's

Welcome Reception for Parliamentarians on the same day. I needed some time to realise how contested my host city is. Cape Town is not in time with South Africa, partly because its racial make-up and attitudes differ from other provinces.

Adolf Ogi's impact

On my agenda as Consul General the contact to nongovernmental organizations, the support and assistance to Micro Business and the involvement in integration and cultural projects in the disadvantaged areas of the Cape Flats played an important role. Several initiatives resulted from the visit in Cape Town of Adolf Ogi, the United Nations Special Advisor on Sport for Development and Peace. Ogi gave speeches at workshops at the Western Cape University and visited projects in townships. After only 3 months in my position, Ogi's visit opened the doors to valuable contacts for future projects in the field of development and sport.

The business climate between South Africa and Switzerland is a positive one. While visiting Cape Town in 2007, the Swiss Secretary of State, Michael Ambühl, reiterated the Swiss intention to use South Africa as an anchor country for its exploration of opportunities within the African Continent. In close cooperation with Pro Helvetia Cape Town my Office took part in many cultural projects.

Cape Town as the legislative capital of South Africa had a big impact on my work. The relationship between my office and the Parliament were excellent and versatile.

New Swiss Ambassador to South Africa

Rudolf Baerfuss is the new Swiss Ambassador in South Africa. In December he met with the South African president Kgalema Motlanthe.

Rudolf Baerfuss, new Swiss Ambassador to South Africa, arrived in Pretoria on 23 October 2008. He is an economist (Universities of St. Gallen and Zurich) and he did postgraduate studies on development at ETH-Z.

He entered the Federal Department of Foreign Affairs (FDFA) in 1977. His first postings were in Bern and Lisbon. He returned to Bern in 1979 and was

attached to the Division of commerce at the Federal Department of Economy (FDE), today Seco. He was then successively posted in Brasilia and Brussels. In 1986, Rudolf Baerfuss joined the Bureau of Integration FDFA/FDE and participated in the negotiations on the European Economic Area. In 1993, he joined the Federal Office for Environment, Forestry and Landscape, as Head of the International division. In 1996, the Federal Council appointed him as Ambassador and Head of Political Division V, Coordination (FDFA). As an Ambassador,

Rudolf Baerfuss successively served in Mozambique and Angola, with residence in Maputo, and Brazil until Summer 2008.

Rudolf Baerfuss wishes to focus throughout his mandate on emphasizing sustainable

development, intensifying the political dialogue between the two countries, further improving

the bilateral economic ties, strengthening the cultural relations, working with young people and making a contribution to skills development in the country. This is the core message that Rudolf Baerfuss delivered to H.E. Kgalema Motlanthe, President of the Republic of South Africa, to whom he presented his credentials on 11 December 2008 in Pretoria.

Mr Baerfuss is married with Ms Beatrice Baerfuss and has two adult sons.

New Head of Chancellery

Since mid January the Chancellery of the Embassy in Pretoria is headed by Pia Gallegos Müller who arrived with her family from Buenos Aires.

Darüber hinaus gilt es auch dem Vorstand der Swiss Parents Association zu danken,

dessen unermüdlicher Einsatz kaum genügend gewürdigt werden kann.

Ursprünglich wurde die Swiss Parents Association gegründet, um sicherzustellen, dass mit den getätigten Investitionen die finanzielle Gleichbehandlung von Schweizer Schülern gewährleistet ist. Dieser Zweck ist seit langem nicht mehr gegeben und die Association versteht sich heute als Organisation, die im Sinne eines „good neighbour“ tätig ist und es mit ihren Aktivitäten der Schule ermöglichen will, Schüler von früher benachteiligten Volksgruppen zu unterstützen.

Die offizielle Eröffnung steht noch aus, wird aber sodann allen Beteiligten die Gelegenheit geben, sich dieses bleibende Zeichen eines schweizerischen Beitrages zur Verständigung der Menschen untereinander anzusehen.

The President of the Swiss Council of States visits SA

The President of the Swiss Council of States, Christoffel Braendli, paid an official visit to South Africa between 30 October and 7 November 2008. He was invited by the Speaker of the National Assembly, H. Hon. G. Mahlangu-Nkabinde.

The main objective of this visit was to foster the relations and the cooperation between the Swiss and the South African parliaments. During the first part of his official visit in Pretoria, Christoffel Braendli met with H.E. M. Mangena, Minister of Science and Technology, as well as with H.E.S. van der Merwe, Deputy Minister of Foreign Affairs. In Cape Town, the President of the Council of States discussed with H. Hon. Mahlangu-Nkabinde and her delegation about the state of the relations between the two parliaments, and paid a courtesy call on Parliamentary Leader of the Opposition Sandra Botha (Democratic Alliance). Christoffel Braendli also took the opportunity to visit a project related to the issue of HIV/AIDS, led by the Swiss Agency for Development and Cooperation (SDC) in Diepsloot, as well as small and medium enterprises supported by the Swiss State Secretariat for Economic Affairs (Seco) in Cape Town.

Federal Councillor Doris Leuthard visited the country in 2007 and, earlier this year in Switzerland, Federal Councillor Micheline Calmy-Rey and H.E. N. Dlamini Zuma, Minister of Foreign Affairs, signed a Memorandum of Understanding. The

official visit of the President of the Council of States, on the highest legislative level, completes the effective cooperation between the executive powers and represents a further step in strengthening our bilateral relations.

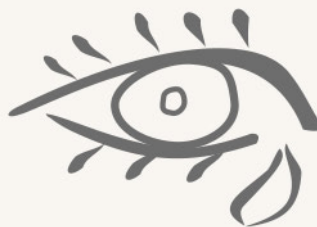
