Consular meetings of the Regional Consular Centre Pretoria and the Consulate General in Cape Town

As part of the development of their services towards

Swiss citizens the Regional **Consular Centre of the** Embassy in Pretoria and the Consulate General in Cape Town are organizing consular meetings in their respective consular districts throughout the year 2012.

A Swiss consular representative or team will be available at the following places and dates:

Mauritius (Quatre Bornes) 7.-9. May; Kwazulu-Natal, South Africa (Durban) (SA) 4.-6. June: Namibia (Windhoek) 26.-28 June; Zimbabwe (Harare) 30. July -1. August; Angola (Luanda) 11.-14. September ; Malawi (Lilongwe) 15.-16. October; Zambia (Lusaka) 7.-9. November.

Swiss citizens will have the opportunity, amongst other things, to apply for a Swiss passport without having to personally travel to Pretoria or Cape Town. Please use this opportunity to make direct contact with a representative of the Regional Consular Centre or the Consulate General. You can, of course also raise other matters that may be of concern to you and at the same time register or update your contact details. If you wish to order a new passport you have to present yourself personally at the meeting due to biometric data that is required for the new passports. Please check if and for how long your current Swiss passport is valid.

The first visit already took place in February in Gaborone, Botswana.

Closer to the indicated dates all Swiss citizens registered in the state or province mentioned will receive a letter from the Embassy or the Consulate General with detailed information about the venue. It is therefore important that you register your current email address and/or your

postal address. You can do that by sending a e-mail to: southernafrica@eda.admin. ch or for the Swiss citizens living in Namibia to: cap. vertretung@eda.admin.ch.

Election of October 2011 and Auslandschweizer performance

The general election in Switzerland took place on 23 October, and some 135'000 Auslandschweizer world-wide were registered

75 Auslandschweizer world-wide stood for election. They did this in 6 individual candidatures on inland political party lists, and 69 candidates on 14 separate political party Auslandschweizer lists in a total of 10 cantons. Regrettably none of these 75 Auslandschweizer managed to achieve election. This is not surprising, as with the present system, where Auslandschweizer votes are spread across 26 possible cantons from which these Auslandschweizer come and, where they are registered. It is practically impossible for any Auslandschweizer candidate to garner enough votes to make any meaningful showing against inland candidates.

Your delegates have been saying this at Auslandschweizerrat meetings ever since the Auslandschweizer were eliqible to vote and to stand as candidates in 1992. If one gives the Auslandschweizer the vote, then it must be a vote that has a realistic chance of also being elected should one consent to being a candidate. Auslandschweizer are not merely to be regarded as party political list fillers, where the only significant benefit accrues to the party whose list is inserted into the ballot envelope.

Of the 75 Auslandschweizer candidates, 4 were from South Africa, all having been nominated by the International Division of the SVP, whose President is our own ASR Delegate Rolf Schudel. Rolf has stood as a candidate at every general election during the past decade in a number of different cantons without success, and no-one knows better than he, what a hopelessly unfortunate "losing situation" faces a prospective Auslandschweizer candidate.

The 4 South Arican candidates were: Rolf Schudel 232 votes in Canton Basel-Stadt, Mario Valli 448 votes in Canton Schwyz, Josef Züger 536 votes in Canton Schwyz, Walter Müller 1022 votes in Canton Zürich.

For this reason your two delegates will be taking a strong stand in the next 2 years, as the ASR continues the dialogue with the parliamentary groups and the EDA, regarding the proposed new Auslandschweizergesetz, which is supposed to centralize, strengthen and suitably entrench rights and privileges, as well as obligations and duties for the Auslandschweizer.

It is the considered opinion of your delegates, that it requires at least the formation of a 27th canton, called "Fünfte Schweiz" canton, where, as in all other cantons, there will be an election of 2 Ständeräte, and a number of Nationalräte based on the number of Swiss Abroad. Only that way can the situation between the Inland- and Auslandschweizer be described as fair. We look forward to, and invite your feedback and opinions in this very important matter.

Call for possible candidates for election as delegates

Our term of office as your elected delegates has reached the mid-term mark, with elections for a new term starting August 2013 for a 4 year period till July 2017, being less than 2 years away.

This is an appeal to all Swiss in Southern Africa, who feel that they might like to get involved in representing the region at the Auslandschweizerrat (ASR), to consider a possible candidature. You should be in a position to organise your schedule in such a way that you need to visit Europe or Switzerland in March and August every year during your 4 year term. This is necessary as you have to pay for your fare to and from the meetings yourself, so a combination of an ASR visit with business or holiday needs, makes it worthwhile and affordable.

If you, as a delegate, attend a meeting, you get CHF100 as a contribution to your Swiss transport costs and possible parking expenses, All other expenses such as accommodation and food, other than lunch during the meeting, are at your own expense. The undersigned suggests that should you be interested, you try to attend one of the next meetings in

March in Bern, or in August in Lausanne, where you would be able to experience first hand whether such a representative duty interests

Some of the interesting items which occupied your delegates over the past two years include:

Profile of the Swiss in Southern Africa as at 31.12.2010:

There were 10'590 registered Swiss as at the 31.12.2010 in the 10 countries in the consular districts of Pretoria and Cape Town. Of these, some 66% or 7022 are Dual-Nationals, with the balance of 3568 persons or approximately 34% being Swiss only. The breakdown between genders and proportion of children is as follows: Females number 4841 (approximately 46%), Males 3964 (approximately 37%) and Children 1785(17%).

The 10 countries comprising Southern Africa serviced from South Africa with their Swiss populations

South Africa 9071 Swiss; Angola 85 Swiss; Mauritius 600 Swiss; Botswana 58 Swiss; Namibia 320 Swiss; Swaziland 39 Swiss: Zimbabwe 284 Swiss; Malawi 25 Swiss; Zambia 99 Swiss; Lesotho 9 Swiss; Mozambique, with 152 Swiss, also gets our copy of the Swiss Review, but does not get serviced by South Africa.

AHV/IV problems encountered by Swiss abroad
