The President of the Swiss Confederation, Mr Ueli Maurer, represents Switzerland at Nelson Mandela's memorial service

On the 10th of December the President of the Swiss Confederation Ueli Maurer joined the 90 heads of states and many government representatives and eminent persons to commemorate the life and achievements of former South African President Nelson Mandela, who passed away on December 5.

He was welcomed by one of his South African


counterparts, Minister for State Security Siyabonga Cwele, and expressed his condolences to South African leading personalities like Gwede Mantashe, Zweli Mkhize (General Secretary and Treasurer General of the ANC, respectively) and Lindiwe Mazibuko (leader of the Parliamentary Group of the Democratic Alliance). After the Memorial Service at FNB Stadium in Soweto, broadcasted in the entire world, President Maurer stayed in Pretoria to pay his last respects to Nelson Mandela, as his remains lay in state at the Union Buildings on 11th of December. Until the passing of Mr Mandela, Switzerland had usually sent

former heads of state in order to honour late former heads of state. With regard to Mr Mandela, it was therefore an exceptional gesture, that an acting head of state came to pay his respects to a late former head of state. This also shows the importance given by the Swiss Government to Mr Mandela's achievements.

E-voting draft presented in March

Auslandschweizer, it was announced that the draft version will most probably be presented at the March 2014 meeting in Bern. The important aspects are:

- Consolidation of all Auslandschweizer interests in one department
- Elimination of discrimination of Auslandschweizer
- Furtherance of mobility of Auslandschweizer

Slow progress on Auslandschweizer bank account issue

Another very interesting debate is what appears to be the unjustified handling of Auslandschweizer bank accounts / holdings by Swiss Banks. This matter is receiving attention from the ASR, but due to constant pressure from the USA and certain EU countries against the Swiss banking industry, progress is slow.

Last but not least, I wish to take this opportunity and once again thank Peter Müller, who represented Southern Africa in the ASR for 35 years, and Rolf Schudel for their outstanding contribution as ASO Delegates to the Auslandschweizer and their families.

The three I have before me are:

1. Moitié – Moitié by Les amis de la Gruyère

There are some 16 songs and dances on this CD, some new, others rewrites of original compositions. A pleasant recording which would more admirably suit a Swiss community abroad with some French-speaking Swiss.

2. Mosibuebä : Vo früener bis hüt

News from the foundation governing the Auslandschweizerplatz in Brunnen

As you know, the undersigned is one of the Foundation members looking after this Auslandschweizer property since its acquisition 20 years ago. The site is the beginning and/or the end of "Weg der Schweiz" which was inaugurated to celebrate the 700th Anniversary of Switzerland in 1991.

The property was originally acquired for +/-CHF 2 million from the adjoining Hotel
Waldstätterhof.

Essentially it is part of the Brunnen Esplanade and serves as a well frequented public open space although it is in private "Auslandschweizer" hands.

As a result of various rezoning attempts, it could be that the value of the land could be reduced as a result of it being essentially a public open space with various building restrictions.

The Foundation of which the undersigned is a member, is fighting to retain the value, yet at the same time, trying to co-operate with the wishes of the Brunnen Muncipality. Needless to say, the dilemma of a public open space being in private hands, will have to be solved if one is to come to an agreement.

Building Platforms for Creative Collaboration in the SADC region

Pro Helvetia Johannesburg has, since 1998, been investing in transnational collaborations, exchanges and joint projects among organisations and creative practitioners operating across the SADC region, with support from the Swiss Agency for Development and Cooperation (SDC).

They intend to use this year, 2014, to refresh and renew the existing approach in this area, with a view to providing a basis for medium to long term investments in networks and platforms that have a shared interest in building a stronger regional creative fabric.

In this context, they are inviting organisations that have either an established or emergent engagement in this area to propose a joint initiative or project that would involve partners in at least two other countries in the region, and which would in turn furnish a basis for developing plans for a more

extended collaborative engagement over the ensuing 3-5 year period.

In 2014 they have the possibility to fund up to 4 initiatives on a modest scale (circa ZAR175 000) to develop and test possibilities for enabling future regional collaboration among organisations that would address one or more of three broad priorities that they think are important based on their past work in this area:

- The circulation and presentation of new work and creative talent across the region, building new markets and audiences
- The development of the professional capacities of creative practitioners and organisations
- Regional cooperation in the area of cultural policy research, advocacy and lobbying

Under this definition the SADC region is understood to include the following countries: Angola, Botswana, Democratic Republic of Congo, Lesotho, Madagascar, Malawi, Mozambique, South Africa, Swaziland, Tanzania,

Zambia, and Zimbabwe.

SDC: Highlights of the coming years

The regional programme
Southern Africa will combine both instruments of
Development Cooperation
and Humanitarian Aid. SDC
will improve its articulation
of its regional approach
with its country offices, the
global programmes and UN
agencies active in the region
and supported by SDC.

In view of the limited means of SDC, the concentration on two out of previously three domains of intervention will increase its efficiency and effectiveness:

Agriculture/Food security: Increased resilience in food security in particular of smallholder farmers in SADC region with a focus on the promotion of a harmonised seed system, post harvest management and Disaster Risk Reduction.

HIV/AIDS: Prevention of HIV/AIDS among young

women and men and access to care and support to contribute to the overall goal of reducing HIV/AIDS incidence and vulnerabilities in particular among children and youth.

Governance (equitable, responsible and accountable allocation and use of public resources in the two domains) and gender (agriculture women farmers, vulnerability of women and girls in HIV/AIDS) will be tackled as transversal themes.

In the regional Programme Southern Africa (RPSA) the approach will bring together regional policy interventions and their translation into selected countries where also interventions on the ground and pilots are taking place. The component in Zimbabwe will contribute to the regional objectives in agriculture/food security and HIV/AIDS. Water, as a key component of food and health security, will be also addressed. Part of the flexible budget will be allocated to health or governance issues in a broader perspective depending on the context's evolution.

Beyond the RPSA, the Global Programme Climate Change will increase its mitigation portfolio focused on South Africa.
